What is Cross-Instutional Program

A cross-institutional program is a program of study comprising a course, or a set of courses of study being undertaken with one provider (the host provider eg Deakin University) as part of a course of study for which you are enrolled with another provider (the home provider – FedUni).

If you are currently enrolled in a FedUni program and wish to study at another Australian institution (host institution) you may apply to study single courses on a cross-institutional (outbound) basis.

Application Closing Date

The attached Application for cross-institutional study (outbound) must be submitted to the relevant FedUni school by the relevant semester.

You will receive written notification of the outcome of your application once it has been processed.

Enrolment at Federation University

You must ensure that you maintain your place in your FedUni program by ensuring you are enrolled. This means that if undertaking courses at FedUni and the host provider concurrently, you are still required to enrol into your FedUni program for the relevant semester.

Alternatively, if you are undertaking all courses at the host institution for a given semester, you must submit an Application for Leave form (available from Student Administration) for the relevant semester.

Fees for Commonwealth Supported Students

Cross-institutional outbound students will not be charged a student contribution amount by FedUni, instead, the student contribution amount is assessed by the host provider and may not necessarily be equal to the student contribution amount that would have been incurred had the course of study been undertaken at FedUni.

Withdrawal

If you cancel your enrolment or withdraw from course/s at the host provider, you must notify FedUni of these changes. You need to do this by submitting the relevant paperwork by the semester census date to your host provider to avoid financial and academic penalties. You must also notify your FedUni program coordinator.
